# **TTARP's BUILDING**

TTARP Executive members continue to meet several challenges which goes with constructing a building in Trinidad and Tobago. After attaining all the necessary permissions required; the economic downturn in our society and globally, has put yet another challenge before us.

The standard requirements for a commercial mortgage from a financial institution, requires a business plan to show revenue stream. Unfortunately, all financial advice received has pointed to the glut of commercial rental on the market. Companies are now merging or downsizing their commercial rental space in a need to survive the downturn in the economy.

With this occurrence, TTARP'S dream of constructing a multipurpose building has been put on hold. The Executive members are now aiming at constructing a single storey building to house our Administrative Building. TTARP'S dream now is to start construction in the dry season of 2017.

# **NATIONAL ISSUES**

The National Issues Committee (NIC) chaired by Cecil Paul continues to meet monthly. Members consist of Coreen Jones Robinson, Neville Navarro, Geoffrey Lewis and Patricia Crossley.

They are charged with the responsibility of developing, advocating and representing the Association's position on National Issues and every year they submit TTARP's recommendations to the Government of the Republic of Trinidad and Tobago (GORTT) for consideration in the National Budget. (See Appendix I for our recommendations for 2016/2017).

Some of the new proposals for Senior Citizens are: - (1) property tax relief; (2) discounted airfares to and from Tobago; (3) an open discussion on the national retirement age; (4) provision of bathroom facilities at all public institutions to customers; and (5) extension of the water taxi service.

On a note of major concern to Senior Citizens is the controversial issue of the withdrawal of the Government Assisted Tertiary Education (GATE) Programme to over-50 Senior Citizens of Trinidad and

Tobago. TTARP has been vocal on this matter and described this new policy as discriminatory, unconstitutional and against the principles of Equal Opportunity. As a result of our opposition there is widespread of national condemnation the Government's discrimination on educational advancement for Senior Citizens and opportunity for all. TTARP is currently seeking discussions with the Government to reverse this retrogressive decision.

Members of the National Issues Committee (NIC) and TTARP's Board of Directors are heartened by the many proposals received from the Zonal Committees which represent all parts of the country. It is critical for TTARP members to participate in the democratic process to advance the well-being and interests of Senior Citizens. Proposals from the zones are therefore quite critical to make significant appropriate representation to the Government of the Republic of Trinidad and Tobago and other bodies that influence the interest of Senior Citizens of Trinidad and Tobago.

The Executive Board takes great pride in declaring that our Association is one of the largest if not THE largest association in Trinidad and Tobago with over 33,000 active/financial members.

#### **SENIOR ACTIVITY CENTRE**

The Ministry of Social Development and Family Services has partnered with TTARP to manage this programme of the seniors in the community. TTARP has appointed a Programme Management Committee headed by a Chairman to manage the daily activities of the Centre. The Coordinator, Ms. Ann L. Brown, operates in conjunction with the Programme Management Committee and liaises with the Membership on a daily basis.

The aim of the Centre is to enhance the quality of life of mature citizens by promoting independence, dignity and purpose in their lives. This is accomplished through the reduction of loneliness, boredom and depression at a time when they may experience the empty nest syndrome and are no longer engaged in activity in the work place. Towards this end, activities such as Ballroom Dancing, Aerobics, Yoga, Singing and Tai Chi are conducted from Monday to Friday.

Training courses were provided in making Christmas Craft, Drinks and Desserts and Small Scale Agriculture. These courses ended on August 29<sup>th</sup>.

Another course titled, "From Ashes to Beauty" was conducted by one of our members, Ms. Merle Sandiford. Waste products such as toilet paper/hand towel holders, old magazines and newspapers were transformed into beautiful Wall Art, Waste Paper Baskets and Fruit Trays, etc.

Seniors ventured into the field of Drama which was both enjoyable and enlightening. Ms. Chevron

Cupidore, a Theatre Arts student from the University of the West Indies conducted these sessions. At the end there was a grand Concert/Appreciation Day which also displayed the attractive pieces created from the beauty of waste.

The Centre, in conjunction with the Central Zone, also hosted Interactive meetings designed to educate and bring awareness of current practices in technology. These meetings provided the forum for obtaining information from persons with specialized knowledge in various fields such as film, HIV/Aids education, consumer guidance, beauty tips and reflexology.

The Tai Chi class participated in Martial Arts Demonstrations at the Chaguanas Indoor Sports Centre. The In-House Choir, 'The Golden Voices' responded to the 'cry for help' when we performed at the Centre's Mothers' Day functions.

Our Fundraisers were well supported by members and well-wishers. These included, interalia, the annual carnival lime held on February 04<sup>th</sup> which provided the usual fun and laughter generated by the portrayals, calypso and the dancing skills of the Seniors and our annual Bar-B-Que held on July 23rd.

These activities are usually well attended and appreciated by the membership and are in keeping with the aims stated in the document 'Establishment of Senior Centres.'

Although we have had several challenges during the period under review, it certainly will be remiss of us if we do not say a special 'thank you' to several bodies who played a part in making the past year a success. Our Thanks go out to our parent body TTARP, the Ministry of Social Development and Family Services, the Ministry of Community Development, the

members of the Board, the members of the Management Committee, the members of the Entertainment and Fundraising Committee who assisted in no small measure in making our activities the success they were, our hard working Coordinator, Ms. Ann Brown and our two (2) On the Job Trainees, Ms. Giovanna Ragoonanan and Ms. Jamiyla Thomas and last but not least our members and well wishers.

#### **HEAD OFFICE ADMINISTRATION**

The Head Office Administration has suffered a great lost with the passing of its Chairman Mr. Arthur Mc Shine on the 22<sup>nd</sup> April, 2016. His ability to dissect, direct and offer options on various topics is a loss, not only to TTARP but all of Trinidad and Tobago. May he rest in peace.

The Admin Committee has partnered with the University of the West Indies on Work/Life Balance and Ageing in Trinidad, the project was launched on 31<sup>st</sup> March 2016 at SALISES Conference Room on UWI St. Augustine Campus. This study will offer ways to understand increase stress and challenges for working people who are ageing and still have increase responsibilities. This study was prompted as it is estimated that within the next 50 years, countries will see a steep increase in the elderly population and a decline in their prime working-age population. TTARP is honoured to be part of this meaningful research.

TTARP on a daily bases, receive request from Employers who are seeing assistance in filling positions with experience, committed and qualified Senior Citizens. TTARP has been able to fill a number of position and both employer and employee (TTARP Members) are delighted with the outcome.

This has prompted TTARP to look closer at its Skills Bank database and we are in the final stages of signing a contract with an Employment Agency to formalize this benefit to members. TTARP invite all members from every field of work to send in their résumé, it MUST however be emailed.

On Wednesday 18<sup>th</sup> May, 2016 the Administrative Committee hosted a training Workshop for all the Zonal executive titled "Moving Forward with TTARP" at Maritime Plaza, Level 2 Conference Room in Barataria. This workshop was sponsored by Development Finance Ltd (DFL).

The History of TTARP was outlined by Mayling Younglao, Michelle Nunes discussed the benefits of a TTARP Membership and Coreen Jones Robinson, described the objectives of the workshop. Understanding the Bye-Laws, Regulations and their Provisions were explained by Attorney-at-Law, Mrs. Sonji Pierre-Chase.

The Guided Recap of TTARP's Bye-Laws sharing Circles comprise members of different zones, they focused on the day's activities and the way forward for TTARP. The success of the workshop was evaluated which resulted in a special committee being appointed to disseminate, review, analyze and make recommendations on the positions as it relates to the zonal groups.

With the growth of membership, the work load has increased significantly for the office staff. Interestingly enough, the front staff of two persons has not increased since the inception of the organisation twenty-three years ago.

We have been able to do so by improving technology – such as moving away from typing and laminating paper cards to printing plastic cards. This has enabled us to maintain the same membership fees for the past five years.

# Appendix I

# TTARP Budget Proposal/Recommendations for 2016/2017

# MINISTRY OF FINANCE

# **Proposals/Recommendations**

- a. The National Insurance Pension should carry a guaranteed period of ten (10) years. In the event of death of the pensioner before 10 years have passed, the full pension should be paid to the beneficiary for the balance of the 10 year period.
- b. The qualifying age for receipt of the Senior Citizens Pension should be reduced from sixty five (65) to sixty (60) years, and a means test should be introduced.
- The NIS Pension should be on par with the Senior Citizens Grant.
- Public Servants Pension should be pegged to the salaries at which the public servant retired.
- e. Government retirees who are widows and receiving a reduced monthly pension of \$2,750.00 shall be paid the minimum government retiree and senior citizens pension of \$3,500.00 per month, together with the arrears (from 2010).
- f. Government should encourage the practice of indexation to government pensioners – based on the increase of cost of living or make periodic adjustments.

## Rationale

This is consistent with existing practices in the pension/insurance industry.

Some high income earners do not need this pension.

Contributions are made to NIS as against noncontribution by recipients of the Senior Citizens Grant.

There are varied formulas for the varied classification of jobs and workers. This recommendation is consistent with industry practice.

The minimum monthly pension afforded to Government retirees and old age pensioners is now increased to \$3,500.00. However, government pensioners who are widows receive \$2,750.00. This anomaly needs to be corrected.

To alleviate the hardships incurred as a result of the rising inflation rates and to avoid disadvantages. Government Pensioners who worked and contributed tremendously to the development of the country express a feeling of betrayal as senior citizens pension recipients who have not worked, are receiving more benefits than some Government Pensioners.

# **Proposals/Recommendations**

- g. An arrangement should be made for all gratuities etc. to be paid to all Government employees <u>immediately</u> upon retirement thereby reducing the backlog of pension/gratuities to retired public officers.
- h. The "Pension Reform Working Group" should review all aspects of Pensions and Welfare Grants. TTARP should be represented on the "Pension Reform Working Group".
- i. Introduction of tax allowances for those financially supporting their dependent relative age 60 and over.
- j. Reintroduction of Tax Incentives for Credit Union Savings.
- k. i) The Ministry of Finance should establish a framework and criteria for dealing with disbursements to authorised NGOs.
  - ii) The financial year of all NGOs should be in harmony with Government's financial year.
  - iii) Disbursements should be on specified dates similar to how salaries and Pensions are done.
  - iv) A unit of the Ministry of Finance should be set up to deal with these disbursements in order to avoid delays caused by line Ministries not seeking or obtaining their releases on time.
  - v) Budget of the NGO should be the basis on which the Subvention is determined. Input from the Line Ministry should be sought. This should be clearly communicated to the NGO.

#### Rationale

This is a major source of complaint from pensioners. Arrangements for pension payments should commence at a minimum of two (2) years before actual retirement with a view to timely pension payments.

TTARP is the largest representative of retirees and stakeholder group in Trinidad and Tobago and therefore should be a stakeholder of the "Pension Reform Working Group".

This encourages appropriate recognition and support of individual family members who bear the financial responsibility for the aged (and) disabled among the family.

To encourage individual and national savings.

Subventions are received late by several NGOs resulting in insufficient funds to manage the various programmes. Most times there is a breakdown in communication so NGOs are left with some level of uncertainty.

# **Proposals/Recommendations**

- vi) Reporting requirements of the NGO should be clearly defined.
- vii) The relevant human and or financial resources to enable proper reporting should be undertaken by the Ministry of Finance if this resource is not available to the NGO.
- I. Review of current NIS payments.
- m. Option of either a lumpsum or a monthly NIS payment for those making in excess of 750 payments.

- n. Public servants should receive both full pension and NIS.
- Banks should provide seating accommodations, ramps and a designated teller on special days for senior citizens as well as for their challenged customers.
- p. The government should regulate the unfair bank charges, interest rates and bank balances penalties instituted by commercial banks.

## Rationale

After 750 contributions, each additional 25 contributions made would result in incremental payments added to the monthly benefit. Members have not been receiving this.

This will allow members to choose as those who make less than 750 can receive a lumpsum, but those who make much more contributions are often not able to recover the amount of contributions paid as often people die without receiving much or sometimes any benefits. In addition, the option to will payments to a loved one for a specific period of time, as if one dies soon after he is eligible to receive benefits, all is lost. The benefits are payable for the contributions taken from salaries of members and should not be lost but be allowed to benefit a loved one.

As both would have been accrued by payments/contributions made by public officers.

To avoid hardships experience by senior citizens and the challenged at banks.

Commercial banks have been instituting unfair policies on customers particularly senior citizens.

# MINISTRY OF HEALTH

# **Proposals/Recommendations**

- The Government should advance the National Health Sector Reform with a view to implementing: -
  - (i) A National Health Database system;
  - (ii) Issuance of a National Medical Card;
  - (iii) The improvement in the quality of C-DAP pharmaceuticals and to ensure availability from varied sources. Distribution should be closely monitored to avoid wastage, etc. Also inclusion of alzheimer's medications in the C-DAP plan;
  - (iv) All State Health institutions and other facilities should be operated, with adequate security on a 24-hour basis or beyond the "normal" operating hours. All necessary medical services should be adequately staffed with the required personnel in order to meet the needs of citizens. TTARP can provide volunteer support at these government operated Health institutions and other facilities in the respective zones
  - (v) Visiting Mobile Units should provide health services to rural areas;
  - (vi) Priority should be given to regular public health education programmes, promoting healthy life styles.
  - (vii) Visiting nursing care to homes should be expanded with senior citizens among the priority clients.

#### Rationale

The increase in numbers of senior citizens and the need to improve health care in the country for all.

This is consistent with International Health recommendations.

Many complaints have been made by citizens on the quality of medications and shortages. Medication should be made affordable for senior citizens who have chronic diseases such as alzheimer's, heart disease, diabetes and other. It is imperative that medication for senior citizens be of the highest quality. It has been proven that the older one gets the more sensitive one is to medication. Most seniors cannot tolerate the generic form of medication.

This will reduce the delays in treatment at the major Health institutions. This will also be an opportunity for the Government and TTARP to enter into partnership.

There is a need to have a more intensive programme.

This will, in the long run, reduce medical costs.

This will greatly support families of the elderly and discharged patients who are in need of continued nursing care to aid recuperation.

# **Proposals/Recommendations**

- Dedicated Cardiac centres are urgently needed with sufficient echocardiography machines and cardio technologies.
- c. Preferential treatment and a special day and time should be given to senior citizens who attend health institutions for medical attention, collection of medication and all other related services. Home delivery of medications should be provided to senior citizens.
- d. A "National Geriatric Hospital" is urgently required and should be established for both teaching and patient care.
- e. A Special Diabetic Institute is urgently needed with emphasis on outpatient care and preventative medicine.

- f. Hospitals and Health Facilities should have visiting Chiropodists (Podiatrists). The serious shortages and/or non-existent of medical specialists should be addressed as a matter of urgency.
- g. Due to the high rates of heart attacks and diabetes, glucose and cholesterol testing should be included among the compulsory tests to be performed during visits to health institutions. Registered NGO's should be given assistance to perform blood pressure, glucose and cholesterol testing.

# **Rationale**

This will allow for timely diagnosis and treatment of heart-related ailments.

To reduce the experience of frustration and address the dignity of senior citizens.

Specialist medical attention for ageing diseases is sadly lacking. Increase in ageing population is also a factor. This recommendation should be immediately addressed by the Ministry of Health.

Due to the alarming increase in diabetes in the country, a separate institution is vitally needed. This will avoid further complications of patients such as heart, kidney, liver, bone and joint diseases.

An appropriate internationally recognized diabetes company should be contracted to educate relevant health personnel on all aspects of diabetes with a view to improving diabetes diagnosis, management and treatment competence.

To reduce the high rate of amputation of lower limbs due to Diabetes.

Seniors waiting time at Hospitals and Health centres are very long. Private institutions are too costly for specialist medical attention.

# **Proposals/Recommendations**

- h. Government, as a matter of urgency, should embark on an exercise of manpower planning for the health sector with a view to determine more precisely the types and numbers of specialist medical personnel and allied health practitioners needed and partner with local and other relevant educational and professional development institutions with a view to inform the public and provide incentives/inducements for studies and certification in the areas of need.
- i. The Ministry of Health should monitor the contents of inputs into food products to ensure safe and healthy levels.
- j. Adequate medical health in Tobago.
- Priority should be given to Prevention k. programmes. The Ministry of Health, through the Regional Health Authorities, should strategically plan and enhance staffing and equipment capabilities in the areas of prevention programmes to avoid more catastrophic interventions (eg. for diabetics - wound care to prevent amputation; osteoporosis - to minimize the number of osteoporotic related fractures; Strokes - early treatment of patients when hospitalized will improve recoverv outcome; cardiac rehabilitation - to improve outcomes after onset that will decrease re-hospitalisation).

#### Rationale

This will provide i) guidance for qualified citizens abroad wanting to return home; ii) career planning and implementation for current citizens; iii) information on the gap which could be filled by importation of qualified foreigners and iv) overall, address the acute shortage of health care practitioners.

To promote a healthier population.

The new Hospital in Scarborough, Tobago needs to be adequately staffed with qualified medical specialists and allied health personnel. Additionally, adequate training of appropriate personnel in the use of all new equipment should be made available.

Physical medicine comprising physical therapy, occupational therapy and speech therapy, when initiated early, can significantly improve the rehabilitative /curative outcomes for patients. This can also decrease the length of stay and rehospitalisation.

# MINISTRY OF NATIONAL SECURITY

# **Proposals/Recommendations**

- a. A partnership in Community Policing should be established between the Ministries of National Security and Social Development and Family Services in the provision of protective services to senior citizens and the disabled. The laws relating to such crimes should carry more severe punishment.
- b. Provide a broader and more effective distribution of CCTV coverage throughout Trinidad and Tobago.
- c. Senior citizens attending national events should be given special access passes to allow for easy access. This should apply in situations when roads to the event are to be blocked off for security reasons.

#### Rationale

The Community Comfort programme should be expanded and enhanced. There is need for the gathering of intelligence on senior citizens in the respective areas, who may be at home, alone and plan for their protection. This could reduce the incidences of violent crime on senior citizens.

Proper maintenance programmes should be implemented and executed to ensure the proper functioning of the system.

Senior citizens experience great discomfort and inconvenience, having to walk for long distances to these events.

# MINISTRY OF SOCIAL DEVELOPMENT AND FAMILY SERVICES

# **Proposals/Recommendations**

- a. At all government and other public institutions, there should be dedicated, trained staff and special days per month should be designated to provide service/treat with the concerns of senior citizens (passport, driver's license etc.).
- Additional Government funded Senior Activity Centres should be established in all districts with government sponsored transport.
- c. Special consideration and recognition should be given to "centenarians" being made wards of the state. In this regard, improvements in the quality of life should be the objective. TTARP is available for consultation on this issue.

#### Rationale

To provide dignified treatment of seniors who experience challenges as they advance in age.

Healthy seniors place less burden on society.

In addition to the recognition they are given by the Ministry, tangible support will allow them to continue giving support and encouragement to their fellow-man and to maintain a suitable standard of living.

# **Proposals/Recommendations**

- d. The Regional Corporation should institute measures to target a high degree of self sufficiency of essential services such as Health, Police, Five, Education and Social Services.
- e. In all new housing developments and other appropriate areas, senior citizens communities with accommodation for singles, couples and small groups should be established with the necessary infrastructures and amenities.
- In keeping with the recently revised Homes for Older Persons Act No. 20 of 2007, TTARP should be represented on the Ministry Social Development and Family Services Oversight Committee and each and every other Committee. TTARP should monitor to ensure the proper enactment of this legislation. TTARP should also partner with the Ministry in making recommendations for the proper operation and continuous evaluation of the operation of these homes and other care facilities for older persons.
- g. Government should provide a subsidy for home care expenses for the elderly and persons with disabilities.
- h. TTARP should provide services as Advisor to the Government (in particular, Ministries of Social Development and Family Services, Health and Public Utilities) on all issues relating to the welfare of our senior citizens.
- The Ministry should ensure that all public buildings and other facilities (including walkovers, pavements, buses etc.) are provided with physical amenities and are made "user friendly" for all, including senior citizens.

#### Rationale

The decentralization of essential services to citizens can create a high degree of efficiency empowered by the community.

Increasing quality of life and longevity of senior citizens.

This is to ensure that adequate standards are maintained at these homes and to uphold the dignity of senior citizens.

This is due to the high cost of home care and to also maintain the dignity of these citizens.

TTARP, in particular with its zonal structure, has greatest on-going contact with seniors regarding their concerns, issues, problems etc.

This is a right established by the International Community.

# **Proposals/Recommendations**

- j. Ministries and other public institutions should make it mandatory for all employees, from the age of 50, to be exposed to training seminars and sensitization interventions, in preparation for their retirement from the world of work.
- The Burial Benefit offered to eligible Senior Citizens be increased to \$7,500.00 to match NIS burial benefit.
- I. Ambulance, "Dial-a-Ride, ELDAMO and other existing transportation support facilities be expanded to include assistance to senior citizens (especially those who live in residential/rural areas not served by public transport and who do not have their own transportation or the necessary family support) who experience emergency and transportation problems.
- m. Persons with mobility challenges using wheel chairs, home elevators and other devices should be exempt from Value Added Tax (VAT) on purchase of such devices.
- The PTSC Bus Service should be improved by at least an additional vehicle at slow hours.
- o. Dial-a-Ride should be instituted.

#### Rationale

To assist retirees in overcoming the negative aspects of retirement such as income adjustment, loneliness, depression and the sense of alienation after retirement. TTARP and the Division of Ageing should be partner in making retirement - otium cum dignitate (leisure with dignity) positive.

To assist in lessening the financial burden of burial expenses.

To support the thousands of Senior Citizens who are unable or have severe difficulty travelling to health and other facilities to conduct their affairs.

Note: For ease of administration of this system, eligible Seniors can be allowed to select a designated driver who will be screened, approved, registered and paid by the participating Ministry/ies to provide a stipulated number of transportation support to grocery, clinic, church, bank, activity centre etc. This system should take effect January 1, 2016.

This is to reduce the cost of these expensive devices to seniors.

To provide a convenient period for seniors to travel and avoid competing with others at peak hours.

This will enable seniors living in certain areas to be more independent. The drivers could be community based and seniors advised of the maximum number of requests permitted each month. Systems should be implemented to ensure drivers are paid at specific rates.

# **MINISTRY OF PUBLIC UTILITIES**

# **Proposals/Recommendations**

# Government should assist TTARP by providing a postal reduction or subsidy for the distribution of its quarterly magazine and encourage wider distribution.

#### Rationale

The magazine provides a public service to Seniors with lots of relevant information that could positively impact the quality of their lives.

# MINISTRY OF WORKS AND TRANSPORT

# **Proposals/Recommendations**

- a. Public transport in remote and rural areas in which currently there is none should be instituted.
- b. The government should consider expanding the water taxi transport system to relieve road congestion.
- c. All 'walkovers' should be fitted with lifts.
- d. A walk over should be constructed for Tobago/Trinidad ferry commuters on St. Vincent Street.

# **Rationale**

There are places where members have to pay high transport costs. Lesser developed areas do not have more facilities readily accessible and many have to seek them out of their communities.

Peak hours transport have affected the productivity and mental attitude of citizens.

This will enable the elderly and disabled to cross the highways without risks of life and limb. At present the 'walkovers' are challenging even for the able-bodied. This results in many persons risking and sometimes losing lives on our highways.

Passengers/Commuters have great difficulty getting to and from the Tobago terminal and are also exposed to the dangerous traffic along the area.
