# **O**PENING REMARKS

TTARP hosted its first virtual AGM meeting via the Zoom platform on 16<sup>th</sup> December 2021 at Trinebox International Services Auditorium, #10-12 Borde Street, Port of Spain. There were approximately twenty (20) Executive and Zonal representatives physically present and approximately two hundred (200) logged in online.

The meeting started on time and ran smoothly in the normal format as a physical AGM. It was an election year and the following executive officers were reelected to serve for the next three (3) years: - Peter Peña — President; Cecil Paul —  $1^{st}$  Vice President; Geoffrey Lewis —  $2^{nd}$  Vice President; Selby Cole, Reynold

Cooper, Neville Navarro, Francis Raymond and Mayling Younglao – Ordinary Members.

At the first meeting of the new Executive Board, Mayling Younglao was nominated and appointed to serve as Honorary Secretary of the Association. Francis Raymond was nominated and appointed to serve as Honorary Treasurer.

Patricia Crossley, Peter Nock and Emerita Sambrano-Churche were co-opted to bring their expertise and knowledge to assist in the growth of TTARP.

# TTARP NEW ADMINISTRATIVE HEADQUARTERS

The construction of TTARP's Headquarters at #167-169 Belmont Circular Road, Belmont is finally in its completion stages having commenced in April 2021.

Like most construction work, there are always challenges along the way, added to the weather in 2022 there were many setbacks that delayed the completion date and although the first phase of the building was handed over to TTARP in September of this year there are still many areas that needed additional work. In the next couple of months however, we are hoping with individual contractors, the Christmas holidays, the security, phones, internet, air conditioning and outfitting the office, that will definitely take some time, TTARP's headquarters will be a reality.

The executive members however continue to worked diligently daily making all the necessary adjustments needed to be in its Headquarters in 2023. TTARP is extremely fortunate for its President Peter Peña and Hon. Treasurer Francis Raymond for their commitment that has made TTARP's Headquarters a reality. Their tenacity has led to TTARP Signature Building materializing without having to commit TTARP to years of mortgage payments, fund raising activity and maybe an increase in membership fee.

Covid as deadly as it was, enabled TTARP to make adjustment in its spending that was applied to its much-needed headquarters. Added to that, all you faithful members who renewed your cards, although shut in and the merchants that honoured their commitment to TTARP Members our sincere thanks. Your commitment and loyalty made our Headquarters possible.

#### **NATIONAL ISSUES**

The National Issues Committee now under the guidance of Mr. Reynold Cooper submitted TTARP's proposals to the Ministry of Finance for consideration into the National Budget 2023 Fiscal year. Some of the key recommendations we highlighted to the Government were: -

- (a) TTARP health initiatives for the elderly directly to the Minister of Health;
- (b) Lobby the Minister of Finance to be included on the Pension Reform Working Group;
- (c) Lobby Government for rent control for senior citizens living in rental apartments;
- (d) Write to the Minister of Works and Transport to expand the water taxi service to Carenage/Cocorite, Chaguanas and Point Fortin areas; and
- (e) Lobby Minister of Finance for citizens over 60 years in owner occupied property with income below \$90,000 per year to be exempted from paying property tax.

Unfortunately, none of TTARP's suggested recommendations (which can be viewed under Appendix I) were implemented. However, some of the

highlights from the Budget that can affect Senior citizens are listed below: -

- Personal Tax Allowance increase from \$7,000 to \$7,500 per month (from \$84,000 per year to \$90,000 per year);
- One time transportation grant of \$1,000 to recipient of senior citizens pension, public assistance, disability and food support;
- Property tax to be implemented in 2023;
- Air Bridge one way from \$150 to \$200;
- Sea Bridge one way (a) Over 60 yrs. \$25
  - (b) Under 60 yrs. \$75
  - (c) Premium Class \$150
- Online payment option for government services;
- Immediate Fuel price increase.

#### TTARP'S MEMBERSHIP STATUS

With the mandate being relaxed on the use of face mask, many commercial businesses increased their operational days of work back to a full work week. As such TTARP staff who have been assisting members by phone with digital copies of their cards from the comfort of their homes, was asked to report physically to TTARP's Head Office on Tragarete Road on a phase basis.

It was rewarding to see both members and staff eager to reconnect with each other after being shut in for so long. TTARP, continued to operate within strict protocol, with a tent and chairs in front the office and allowing only two members in the office at a time, of

course, keeping their distance, sanitizing and the wearing of mask.

The calendar year saw persons trickling in to renew and to join TTARP. It was an uncertain climate but we knew that things were improving worldwide with the Pandemic.

By May, twenty-eight (28) promoters were willing to accept the challenge of commencing Promotions via our outreach programme at Massy and Tru Valu Stores. And with a staggered schedule we were able to continue Promotions until mid-November.

Outreach Programmes also included, participation at events hosted by Angostura, Ministry of Health, Mount Hope Hospital, Piarco Fire Station, Rodney's Supermarket, COSTATT, NWRHA, Flour Mills, Prisons Service, Bridges to the Heart, CCSL, St. James Medical and Coca-Cola.

Collectively, the Promoters encouraged over 1,800 new persons to join the Association and assisted over 3,300 members to renew their membership cards, which was quite an accomplishment.

Membership online payments have been increasing as people become more aware of this easy, safe and convenient option. To date, over 7,400 persons have opted to use this method. However, if one needs assistance in renewing online, they can call us at 497-2687; we will be happy to assist.

We thank all our Promoters, for their dedication, loyalty, perseverance and for always going the extra mile.

# **ARIMA ZONAL GROUP**

Members of the Head Table, fellow Zonal Committee Heads, Good morning. I am Carol Bain, Vice Chairman of the Eastern Angels, Arima Zone. Accompanying me on this virtual platform is our Chairman Peter Nock.

After closing down since March 20, 2020, the first virtual Zonal Committee meeting was called via Zoom by the Vice Chairman on September 6, 2021. The purpose of the meeting was about getting back together virtually in this abnormal time. The Committee Heads were told they are the ones to keep the members interest alive and she suggested to them that they explore ways and come back to report on how they would make things happen for the members.

Some suggestions to the Committee Chairs were as follows: -

**Education Chair** – Diabetes and Life Styles, Nutrition/Diet, Seniors/Elderly getting familiar with technology. Contact Mrs. Rouse on virtual presentations for members on Health Issues, Mental Health.

**Events Chair** – Develop a calendar of activities for the coming months to year end and propose a fund raiser.

Tours - Develop a virtual tour program with such organizations as Tourist Board, National Trust of Trinidad & Tobago, sparking interest for online games for members such as Bingo etc.

The subject of election for a new Zonal Committee was discussed and agreed as part of the plans going forward.

Recognition was given to the Events Committee for collaborating and sharing online activities for the Zone's 19 years anniversary celebrations in July 2021. Annette Young was congratulated for her time, dedication and sharing of diabetes information online.

Attending by invitation on October 6, 2021 meeting was Mr Selby Cole, Chairman to Tobago Corals. The purpose was to share his experience and the procedures for having an election online. Mr. Cole offered to assist EAAZ with the handling of its internal election online with the right resources.

At this meeting the Committee Chairs brought in their reports for approval recommending how they would keep members engaged and entertained virtually.

At this meeting a decision was taken for the Chairman to advise the membership that the Zonal Committee was functioning virtually and that they would be seeing results of the Committee's work via WhatsApp. November 3, 2021, Zonal Committee met via Zoom.

It was decided the chairman would put on the Zonal Committee Chat the bank and account number of EAAZ so that committee members would pay their dues quarterly. The purpose was to keep the account from becoming dormant. This was approved and agreed by all members. A schedule was developed for payment for each Committee member of a hundred dollars per

quarter. Members would flash a copy of their receipt to the treasurer.

Nov 14, 2021 - (14) fourteen members went on a 360degree virtual tour of our Heritage site Nelson Island, courtesy National Trust of Trinidad & Tobago.

December 2021 - a virtual Christmas luncheon via Zoom was held on December 3, 2021. This was an interesting idea. Many members joined and one member; although had many personal challenges turned out to be most innovative with his idea of each dish listed on paper, folded and placed in his plate accompanied with his knife and fork.

On January 28, 2022 - via Zoom, the first Monthly meeting for the membership was held. Thirty-two members attended. This was very encouraging. The Chairman welcomed and wished everyone Happy New Year and said we looked forward to 2022, not forgetting our experiences of 2021. Members were advised that election was overdue and the Committee was working on election for a new Zonal Committee by October 2022. The question of face-to-face meeting arose and members were advised according to Health policy Guidelines, we were limited to only 10 persons social gathering.

In February the Events Committee held a taste of Carnival for members. This was a bit of a struggle as few members were interested in a virtual parade. To keep members interested videos were forwarded in the Chat.

The Arima Zonal Committee has returned to running the Zone without 4 elected members, 2 selected members and 1 member ill.

On March 11, 2022 - a virtual Sip and Chat was held for members.

April 11, 2022 - the Zonal Committee met face to face to begin specially planning for complete opening up of the Country, and the Arima Zone.

On May 6, 2022 - the opening of the Zone took the format of an Opening Thanksgiving Ceremony, time 2 to 5 pm at the Arima Tennis Club. Special invitees were the Mayor of Arima, representatives of TTARP, Management of the Arima Tennis Club. Opening prayer was said by our very own member and Pastor Gwendolyn Smith. The choir members provided a rendition of 3 gospel songs. Members who had passed during Covid 19 were recognized by a minute silence, lighting of a candle and their pictures posted on a wall, and members were treated with refreshments.

June 17, 2022 - was our Mother's/Father's Day event. Father of the year winner was Ethan Benjamin and Mother of the year was Ms. Althea Hazelwood. Each winner was presented with a prize. Also, there was a best dressed winner.

The Zone celebrated 20 years anniversary in the month of July. A calendar of events was developed for each Friday: -

July 8 - Mini Health Fair inclusive of Blood Glucose testing, Vision Screening and Health Management; July 14 - members first person to person tour to Trini River Lime.;

July 15 - Karaoke by members as a fund raiser. Seventy (70) members were present;

July 22 - Day of Games and Bingo; and

July 29 - Choir Concert.

On the last day of the anniversary celebrations members were treated with a slice of cake donated by

the Zonal Committee. July was an enjoyable month for all, as it brought back memories of the way it used to be.

August 2022 - Emancipation Day was celebrated by members elegantly dressed in their emancipation outfits. Some members volunteered to model, much to the delight and entertainment of everyone. Tips on Fire Safety Prevention and How to use the Fire Extinguisher was presented by our member Mr. Joseph Maynard. Members were dressed in their national colours Red, White and Black.

Members are still monitoring the Covid situation; as you know we are a vulnerable part of the society. Members turnout have increased to approximately 60/65 persons.

- (1) Partner with the Arima Mayor in providing support to Community activities improving the lives of senior citizens in the Borough, and Police Youth Clubs in the Zonal area.
- (2) Have our AGM/Election for the new Zonal Committee in the first quarter.

- (5) Overseas tour to a Caribbean island.

# **CENTRAL ZONAL GROUP**

TTARP Central aka Central Pride was previously located at the Central Indoor Sports Arena, Manic Street, Chaguanas where various activities were conducted on a daily basis. All activities came to an abrupt end when the Zone closed on March 13<sup>th</sup> 2020 due to the Covid 19 restrictions. However, The Zone remained virtually active through daily messaging on our WhatsApp Chat Groups and virtual challenges.

In April 2022, our attempts to resume activities at the Arena were not successful as it remains closed to outside activities due to problems with their washrooms. As a consequence, we commenced meetings at the Community Centre, Chaguanas, at a cost and was recently given permission by the Mayor, Chaguanas Corporation to conduct our Board meetings, free of charge, in their Canteen. We remain strapped for suitable accommodation to resume our physical activities but are optimistic that we will be more functional in the coming Year.

#### **Activities**

There were seven (7) Virtual Challenges conducted during the period under review. These were held for Republic Day on September 24<sup>th</sup> 2021; the Christmas weekend of December 21<sup>st</sup> to 26<sup>th</sup> 2021; The Carnival weekend of February 25<sup>th</sup> to 27<sup>th</sup> 2022; the Easter weekend of April 15<sup>th</sup> to 18<sup>th</sup>; Indian Arrival Day May 30<sup>th</sup>; Emancipation Day August 1<sup>st</sup>; and Independence Day August 31<sup>st</sup>. On each occasion members were given a specific activity and requested to post pictures

of themselves in action. There was much enthusiasm as members robustly responded to each challenge.

We commenced 2022 with an outreach programme. On January 14<sup>th</sup> 2022, our Chairperson, Faith Calliste, Treasurer, Portia De Silva-Ifill and the then Asst. Treasurer, Ann Williams visited the Beckles Street Home for Senior Citizens to spread some New Year cheer. A sumptuous lunch complete with dessert and tokens were distributed to the residents. Due to the Covid protocols they did not stay around to chat or entertain as usually done but quickly distributed the lunches and tokens, conveyed greetings and departed. The residents expressed gratitude for the visit.

As the pandemic measures eased, we cautiously reopened with a Board Meeting on April 19<sup>th</sup> 2022. Members noted that: -

- Our membership needed to be advised on the way forward; and
- 2. The need to call an Annual General Meeting (AGM) as all positions on the Board were vacant.

Our first Interactive meeting was held on May 19<sup>th</sup> 2022 at the Community Centre, Chaguanas where members were informed of the AGM being planned for June 23<sup>rd</sup> 2022. In preparation for a successful meeting, they were advised of the various vacancies, the duties they entailed and invited to submit nominations for the filling of these vacancies.

TTARP negotiated/implemented for <u>its Members</u> a wide variety of discounts for purchases at numerous Commercial, Medical and Retails enterprises. *These are being added to on an ongoing basis*.

#### **BENEFITS FOR PERSONS AGE 60+**

The following are TTARP's Recommendations to the Government of the Republic of Trinidad and Tobago (GORTT) and others on behalf of <u>Senior</u> Citizens now in effect: -

- Fee Exemption for the renewal of a Trinidad and Tobago Passport.
- 2. Fee Exemption for the renewal of a Trinidad and Tobago Driver's Permit.
- 3. Exemption from Trinidad and Tobago Airport Departure Tax on Airline Tickets.
- 4. Tax Exemption on premium payments for General Insurance Policies (e.g. House and Car).
- 5. Free PTSC Bus Pass for bus rides in Trinidad and Tobago.
- 6. Free rides on the Water Taxi between POS and San Fernando.
- 7. Fee Exemption on certain bank services (e.g. Bank Drafts and bank statements for US Visas).
- 8. Preferential rates on fixed deposits at Banks and certain Credit
- 9. Increased the range of CDAP medications for ailments common to Senior Citizens.
- 10. Extended Medical Care hours of services at community Centers from 7am to 4pm, to 7am to 7pm, and in certain areas from 7am to 10pm.
- 11. Increased non-taxable annual income allowances from \$72,000 to \$84,000 for all citizens.
- 12. The Senior Citizens Grant has been increased to \$3,500 (max) per month dependent on a means test for other Retirement Income from NIS and Occupational Pensions which must not exceed \$5,500 per month.
- 13. Retiring Government employees will now receive an interim pension of three thousand dollars (\$3,000), while their work records are processed, when verified, the retired employee will receive the correct pension and a lump sum for arrears.
- 14. Removal of semi-annual Life Certificate for NIS Pensioners.
- 15. Retired Government Pensioners will no longer be required to present themselves as proof of life existence as an online link will be established with the Registrar General's office.

16. Walk-Over constructed to assist senior citizens and others travelling to and from the Tobago Ferry Port and Water Taxi service.

# OTHER

In context of approved GORTT National Budget 2021/2022 the following are some additional improvements which Senior Citizens (and Others) shall enjoy: -

- a. All first-time home owners will qualify for a tax-free allowance of Thirty Thousand Dollars (\$30,000).
- Employed persons will benefit from a non-taxable increase from Fifty Thousand Dollars (\$50,000) to Sixty Thousand Dollars (\$60,000) for NIS and other contributory Pensions.
- c. Value Added Tax (VAT) has been removed from many basic food items, such as biscuits, cooking oil, canned vegetables, canned meat and fish, cornflakes, curry, juice, sausages, ham, ketchup, pigtail, and bottled water.
- d. Electricity and Water rate rebates to be increased from 25% to 30% for bills LESS THAN Three Hundred Dollars (\$300.00).
- e. Removal of VAT and Duties on therapy equipment for treatment of vision, hearing and physical disabilities.
- f. Removal of VAT and Import duties on computer equipment which should make these important communication devices cheaper.
- g. All Citizens will have access to Free WIFI internet connections at Transport Hubs, Public Hospitals, Schools and Libraries.
